#### Motion for Consideration by the 2019 Virginia Annual Conference

Balancing Lay and Clergy Membership of the Annual Conference

PETITION TO AMEND ¶32, Article 1 (and the same sentence in ¶602.4): "If the lay membership should number less than the clergy members <u>in attendance</u> of the annual conference, the annual conference shall, by its own formula, provide for the election of additional lay members to equalize, <u>as far as possible</u>, lay and clergy membership <u>in attendance</u> of the annual conference."

RATIONALE FOR GENERAL CONFERENCE: The intent of ppg. 32, Article I. of the Constitution of the Book of Discipline, and of ppg.602.4, is to ensure equal representation of laity and clergy at sessions of the annual conference. With the current wording, this is not being achieved in actual practice as well as it could be. The reason is that many retired clergy, clergy serving extension ministries, and clergy on incapacity leave are not able to attend annual conference sessions, due to infirmity, illness, or distant location. There are no alternate clergy members prepared to attend in their absence, as there are for lay members of annual conference. Electing lay persons to balance out such absent clergy requires the expenditure of considerable funds, increases the size of the annual conference session unnecessarily, and does not effectively fulfill the intent of the constitution to provide equal lay and clergy representation.

Effects on the Virginia Annual Conference:

Each year, there are approximately 200 more lay members attending the Virginia Annual Conference session than clergy members. In 2018, there were 1,116 clergy members in attendance. There were 1,306 lay members in attendance. A per diem is paid for the expenses of each at large District member of Annual Conference. This amount is \$200/ day (approximately: each district decides this amount), for 2 days, for 190 lay members attending more than clergy members attending. If this legislation would pass, it would save approximately \$76,000 in apportionments to local churches each year.

I move that the Virginia Annual Conference supports this "Petition to Amend" and its "Rationale" and directs the Secretary of the Annual Conference to forward this petition (excluding the "Effects on the Virginia Annual Conference") to the 2020 General Conference.

Motion to set term limits for Delegates to the Jurisdictional Conference and/or to the General Conference.

Beginning January 01, 2020:

That no elected Delegate shall attend more than three consecutive terms, either Jurisdictional or General Conference, during a six-year consecutive time frame.

If the elected Delegate has completed serving within that time frame, then they cannot submit their application within the next four years. After that time frame, they can then submit and, if elected, attend up to three consecutive terms, within a six-year time frame. They must be elected during each session.
