Annual Conference Offering QR Code

For Annual Conference offering this year, we are excited to share that we will be supporting two important initiatives who are engaged in the work of mission and service in the world. Our first one is supporting the ongoing connectional work with our VAUMC Partnerships of Hope countries: Brazil, Mozambique, Cambodia, Haiti, Vietnam, and Native American Ministries. The other half of our offering will be given towards our conference-wide Undue Medical Debt Campaign (formerly RIP Medical Debt) to help eliminate medical debt in the Commonwealth of Virginia. It is our hope that through this debt campaign, we are able to raise \$390,000 that would help eliminate \$39 million of medical debt that continues to hurt the most vulnerable in Virginia. This campaign will start with the Annual Conference offering and continue through the end of the calendar year.

The Next Faithful Step: A Quadrennial Focus

Bishop Sue Haupert-Johnson called for a gathering of conference leadership, the "Extended Extended Cabinet", beginning in January of 2024 to build relationships, discern directional aims, and develop a common focus for the work of the Virginia Annual Conference in the next quadrennium. This team included the Appointive and Extended Cabinet alongside members of the Common Table and Board of Ordained Ministry.

As part of this work, the team developed clarity about who we hope to become as

a conference that:

- Embodies the fruits of the Spirit to live a transformed life.
- Follows Jesus in a way that leads to disciple-making.
- Practices extravagant inclusivity.

What principle and priorities will guide this hope?

Principle: At God's initiative, the Virginia Annual Conference exists to support the transformation of lives by facilitating Christ-centered connections between individuals, local churches, communities, and across the wide array of God's creation.

Priority: Make time to grow in relationship with God and neighbor.

We, the members of the Virginia Conference, intend to live in Christ's love in such a way that our lives are transformed and exhibit the fruits of the Spirit found in Galatians 5:22-23 and reflect the life and love of Christ.

Priority: Define the practical roles of the Annual Conference, the District, and the Local Church within VAUMC.

 Create strategy allowing for mutual coordination to best resource ministry and mission across the Virginia Annual Conference

What benchmarks will we pursue as an Annual Conference over the next quadrennium to indicate the progress of our journey toward this hope?

- Develop a comprehensive leadership framework.
 - Develop a total framework for leadership deployment in the Annual Conference, to include staffing, boards and agencies, and structure of workflows
- Engage a culture of call.
 - Engagement of practices to raise up new, called leaders to serve in local churches, on districts and within the Annual Conference.
- Build a narrative budget.
 - Create a budget for 2026 (and subsequent years) telling the story of how finances contribute to the mission and ministries of the Annual Conference
- Tell great stories.
 - Navigate telling the truth of who we are and have been, celebrating the wins where they
 take place, and equipping local churches, districts, and the Annual Conference to tell
 stories well
- Emphasize a United Methodist "catechesis"
 - Doing the work of teaching and living United Methodist theology in every United Methodist setting in the Virginia Annual Conference.

How did the work of the "Extended Extended Cabinet" progress?

- Over several months, this team worked together in facilitated conversation to discern the following:
 - Telling the truth of who we have been. (pg. 2)
 - Developing clarity about who we hope to become. (pg. 1)
 - Understanding a guiding principle for how we grow toward who we hope to become.
 (pg. 1)
 - Creating a series of benchmarks can serve as indicators of progress along that journey.
 (pg. 1)

Sharing some truths of who we perceive we have been.

The team followed the model of the Prayer of Confession in order to name and confront truths of the past in order to dream the hope for the Virginia Annual Conference.

God, as we have leaned into you, we are grateful for what you have done in and through us...

- We have been sacramental people centered at the Lord's Table and on our baptism.
- We have practiced the center of our theology, living that Jesus is Lord.
- We have stayed together through many trials and storms.
- We have discovered an ongoing mission unfolding from God in our midst.
- We have developed an open posture to speaking the truth about our shared story.

God, we admit that there are places we as an Annual Conference have fallen short...

- We have failed to be an obedient church.
- We have not loved one another, our neighbors, or your creation with the fullness you intend
- We have seen people as their positions rather than as their creation as wonderful children of God.
- We have maintained a sense of a programmatic mission where existing stakeholders maintain control.
- We have often been connectional in language, but congregational in practice.
- We have been far too committed to institutional preservation and homeostasis as primary drivers, rather than taking risks for the gospel of Christ.
- We have maintained a competitive ideology that has amplified skepticism.
- We have chosen to reinforce a theology of scarcity and have allowed that to lead us more than the enoughness of Christ.
- We have embraced a sense of vision that comes from "on top" rather than from "within".
- We have interacted with one another from a center of rule enforcement instead of on connection and mutuality.
- We have proclaimed diversity as a core value, but have failed to create spaces and cultivate leadership essential to that work.



2024 Virginia Annual Conference Consent Agenda

Conference Standing Rule II.E states: Agenda items and reports not requiring action by the Annual Conference other than a vote to receive said items for publication in the Journal shall be placed on a Consent Agenda. For any item or report to be eligible for placement on the Consent Agenda, it must have been distributed in the pre-Conference materials. Determination of items to be placed on the Consent Agenda shall be made annually by the Bishop in consultation with the Consent Agenda Committee. This committee shall be composed of the Conference Secretary, the Conference Lay Leader, the Chair of the Conference Rules Committee, and the Director of Connectional Ministries. An individual item may be removed from the Consent Agenda at the request of no less than 30 members of the annual conference. The process for making that request will be determined by the Consent Agenda Committee, and the deadline for such requests will not be prior to ten minutes after the call to order of the annual conference session. The Consent Agenda will be made available electronically one week prior to the annual conference. When an individual item has been removed from the Consent Agenda, it shall be placed into the reqular agenda.

The Consent Agenda Committee has determined that the deadline for requests of items to be removed from the Consent Agenda is 4:30 p.m., June 20, 2024. According to Conference Rules, removal of an individual item from the Consent Agenda requires 30 signatures accompanying the request. Motion forms to request removal of items from the Consent Agenda are in the Official Packet, available on www.vaumc.org/AC2024, and at the front of the stage. Completed forms must be returned physically to the "secretarial inbox" at the corner of the stage by the established deadline.

Equitable Compensation Addendum

The Equitable Compensation Commission continues to provide financial aid to those churches requiring supplementation to strengthen their ministries in the communities in which they are located and to provide minimum salary or salary supplementation for the pastors. Equitable Compensation support in the amount of \$168,545 was provided to 27 charges in 2023.

There were 4 charges receiving salary support in 2022 that did not require salary support in 2023. These are Bethel Belle Haven (Coastal Virginia), New Mission (Coastal Virginia), Toms Brook (Shenandoah River), and Pembroke (Valley Ridge). These charges and their superintendents are commended for their success in providing a ministry in the communities they serve that has enabled them to grow spiritually in their stewardship.

District Superintendents and charges setting salaries for 2025 that may require supplementation are advised that the "floor" must come from sources other than the Commission on Equitable Compensation.

The Conference Average Compensation (CAC) for 2025 is \$69,518, which is an increase of 2.5% percent from 2024. The Commission recommends the Minimum Compensation and the Floor Schedule for 2025 be approved as outlined below:

Rules Committee Addendum

Rule VII.L – Add the following new rule and renumber the remaining subcategories under Rule VII.

o <u>Minutes of Annual Conference</u>. The transcript of the video recording of the annual conference session shall serve as the official minutes of the annual conference session once it has been reviewed and approved by the Minutes Committee.

Rationale - This rule change will ensure an accurate and reliable record of the proceedings of the Annual Conference session. As we have come into a technological age that allows for such tools, the Secretary and others feel that it is in the best interest to adopt this proposed rules change for the purposes of upholding the integrity and accountability of the annual conference sessions. This change provides further transparency to the sessions and a better stewardship of the Annual Conference Secretary's time and energy to complete other necessary tasks.

Correction to Page 34.

"Rule V.C.8. In the sentence citing the *Book of Discipline*, insert (¶ 632) for the appropriate citation to the BOD. Remove the five members elected at-large, so that membership on the committee consists of only 10 clergy and 10 laypersons. Strike the sentence beginning, "The district coordinators for Religion and Race shall be..."

Ethnic Minority Concerns and Advocacy, Commission on. There shall be a Virginia Conference Commission on Ethnic Minority Concerns and Advocacy amenable to the Common Table for Church Vitality. The commission will provide for the functions as outlined in the current *Book of Discipline* for the Committee on Ethnic Local Church Concerns (¶ 632). The membership of the commission shall consist of 10 clergy and 10 laypersons elected upon nomination of the Conference Nominations Team. A minimum of two members shall be youth and young adults between the ages of 12-35. The commission will be constituted so that two-thirds of the membership be representative of people from diverse racial and ethnic backgrounds. The presidents or chairs of conference caucuses, fellowships, or associations for racial and ethnic constituencies shall be ex-officio members of the commission with voice but not vote. The bishop may appoint to the commission a district superintendent to serve as Cabinet representative with voice but not vote."
