VUMPI Open Enrollment

Open enrollment for the Virginia Conference health benefits in 2025 will begin on **Monday, October 7** and runs through Thursday, October 31. Health plan elections for 2025 will be made using the Unity Web system. The same health plans will be made available in 2025 as in 2024.

Participant contributions across all medical, dental and vision plan options will be unchanged in 2025. There are no plan design changes to any of the plans in 2025. If no plan elections are made in the Unity Web system, current enrollees will remain enrolled in the same health plans in 2025 as in 2024. Only Medical Flexible Spending Account and Dependent Care Account participation need to be actively elected each year.
