# **2024 Apportionment Results**

In 2024, we collected 82.0% of the budget approved by the Virginia Annual Conference. This was a 1.7% increase from what was received in 2023. There were 561 churches that paid 100% of Conference Apportionments in 2024. Churches gave an additional \$1.1M in Second Mile giving last year. See page 2 for additional details.

# **2026 Direct Bill – Clergy Health Benefits**

Beginning January 1, 2026, the Virginia Conference will change how the Conference-sponsored health benefits for active clergy are funded. Currently, the majority of the funding for the active clergy health benefits comes from Apportionment #407 – Active Clergy Health. In 2026, the apportionment will be replaced by a flat amount that will be directly billed to churches for each health-plan eligible clergyperson. Local church leadership who has questions should first use the calculation tool below to assess what this change will mean for their own church.

If you have a Lay Supply Pastor appointed to your church, be sure that you withhold Social Security and Medicare, as well as Federal and State taxes. Give us a call if you have any questions.

### **Update the IRS with the Person Responsible**

It is that time of year to update the person responsible for your church finances with the IRS. The person that you report should be your treasurer/bookkeeper or could be your Finance Chairperson. It is common that volunteers change at the church and the new person is not reported to the IRS when a new person becomes responsible for the payroll taxes and other finances.
