### 2026 Compass and Direct Bill Calculator

In order to help churches prepare for the launch of the new Compass denominational retirement savings plan in January, VUMPI has prepared a calculator that is being made available to clergy and churches. The calculator identifies the annual and monthly billing amounts for Compass, along with the billing amounts for the Comprehensive Protection Plan, or CPP, which is our denominational life and disability insurance plan. The calculator also identifies the new clergy health plan direct bill, which is the way that churches will contribute the employer contribution to the cost of the Conference-sponsored clergy health plan. ## **VUMPI Open Enrollment**

Open enrollment for the Virginia Conference health benefits in 2026 will begin on **Monday, October 6th** and run through Friday, October 31st. Health plan elections for 2026 will be made using the Unity Web system.

Participant contributions for medical and dental will increase approximately 5% for 2026, although varying by plan and dependent coverage tier. Vision rates will be unchanged in 2026. There are no significant plan design changes to any of the plans in 2026.

If no plan elections are made in the Unity Web system during Open Enrollment, current enrollees will remain enrolled in the same health plans in 2026 as in 2025. Only medical Flexible Spending Account and Dependent Care Account participation need to be actively elected each year.
