2026 Apportionments

Local church apportionments for 2026 will be distributed to your district office by Friday, September 5th and then sent out to local churches per each district's schedule.

This year we provided a Budget Narrative that included details of the 2026 Budget. This was released in the Book of Reports at Annual Conference. You can view the Budget Narrative below:

2026 Local Church Budget preparation

Quick reminder that several changes are coming in 2026 that you will need for your Operating Budget:

- 1. Health Benefits for your clergy will be direct billed to local churches beginning in 2026. Currently all churches contribute to the 407-Active Clergy Apportionment, which will no longer be apportioned in 2026. For each full-time active clergy eligible for health benefits, the annual church cost will be \$19,920. The VUMPI bill will continue to also include the employee's portion for health that should be deducted from their paycheck.
- 2. The clergy retirement plan is also shifting in 2026. Currently, local churches are billed from VUMPI for the Clergy Retirement Security Program (CRSP) which ends 12/31/2025. In 2026, the retirement program will shift to Compass which will include the local church contribution and the matching amount that will need to be deducted from their paycheck.

Both the direct bill for health benefits and the retirement amounts will be reflected on the clergy compensation form that will be needed for your local church 2026 Budget.

Local Church Audit

As we begin to look towards the fall and churches are planning their Charge Conferences, the local church finance team should designate an audit committee that is independent to conduct the audit. The Audit Committee should be composed of at least two people unrelated to the treasurer, financial secretary, pastor(s), finance committee chair, business manager, those who count the offerings, or the church secretary. The key to using an audit committee made up of people within the church is *independence*, both in fact and appearance with no bias. They can be members of your church or swapped with members from another church. Go to the online audit guide for step-by-step instructions.
