2021 Apportionments

The 238^{th} Session of the Virginia Annual Conference voted to approve the 2021 Budget in the amount of \$27,850,000. This is a reduction of \$3,600,000, (11.45%) from the Approved 2020 Budget. Since the proposed Budget was approved with no changes, the apportionments that have been distributed for 2021 are final. 2020 Apportionments Prioritized

All churches are asked to pay 100% of Priority 1 Apportionments this year, which is 72.77% of the original apportioned amount for 2020. If your church pays all of Priority 1, your church will be recognized as paying 100% this year. At the end of October, more than 60% of our churches have made payments that indicate that they are on track to pay all of Priority 1. This is a positive sign, as we compare to the same time last year, that 50% of churches were on a predictable pattern of paying 100% of their 2019 Apportionments. We know that many more of our churches will still be able get to 100% of Priority 1 this year based upon their giving history increasing at the end of the year. This is a good indicator that Priority 1 is reachable for most of our churches this year, which was the intent of CFA prioritizing the apportionments.

We encourage all churches that are able to pay all of Priority 1 to support Priority 2 Apportionments as you are able. Keep your District Superintendent informed if your church may not be able to pay all of Priority 1 appointments this year.

Boy Scouts of America – Proofs of Claim

Thank you for the quick response from many church leaders who submitted the paperwork needed to file a Proof of Claim with the Bradley Firm by Nov 2nd. We had over 400 churches to respond. Thanks also to the Council on Finance and Administration (CFA) for voting to cover the cost of the attorney fees to file for the claims.

Tax Status Documentation - 501c3

Periodically churches need documentation of their 501c3 religious non-profit tax status for various reasons (i.e. establishing a bank account). GCFA, our UM national organization, has taken care of this filing for you already. To print this official letter, go to www.umgroupruling.org and complete the information for your church. You will need the church Federal ID#.

GCFA has also taken another step to provide greater documentation for local churches by allowing churches to choose to be listed on GuideStar when you complete the Group Ruling Application. GuideStar is a key website for non-profits to be listed on for donations like AmazonSmile. Banking institutions will also often refer to this source for documentation. Some banks will also ask for the church originating documentation.
