<u>Tax Status Documentation – 501c3</u>

Periodically churches need documentation of their 501c3 religious non-profit tax status for various reasons (i.e. establishing a bank account). GCFA, our UM national organization, has taken care of this filing for you already. To print this official letter, go to www.umgroupruling.org and complete the information for your church. You will need the church Federal ID#.

GCFA also provides greater documentation for local churches by allowing churches to choose to be listed on GuideStar when you complete the Group Ruling Application. GuideStar is a key website for non-profits to be listed on for donations like AmazonSmile. Banking institutions will also often refer to this source for documentation

VUMPI Open Enrollment

Open enrollment for the Virginia Conference medical plans will begin on October 10 and run through October 31. This year, health plan elections will be made in UnityWeb. Carefully review invoices for potential fraud

As we all are raising our awareness relating to invoice fraud, we wanted to share one company that has lured several of our organizations/churches into paying a fraudulent invoice.

An internet company has been sending solicitations that looks like an invoice customized with your church website name for a year subscription to list your church on their website for greater exposure on the web. At the bottom of the invoice, there is a notice that: THIS IS NOT A BILL. THIS IS A SOLICIATION. YOU ARE UNDER NO OBILIATION TO PAY THE AMOUNTS STATED ABOVE UNLESS YOU ACCEPT THIS OFFER.

Federal 941 Tax Form Reminder

Be sure to file Federal Form 941 no later than October 31st for the third quarter ending September 30th.
